Preceding the Reorganization meeting, the Oath of Office was administered to newly-elected and reelected Board Members: Mrs. Jennifer McWilliams, Mrs. Amy Joy Robinson, Mrs. Christine King, Mr. John Gratner and Mr. Michael Rajakovic.

The Northgate Board of School Directors, at last night's Reorganization meeting elected Mr. Gary Paladin as President, and Mrs. Amy Joy Robinson as Vice President. Also, the Board appointed the law firm of Andrews and Price, as represented by Patricia Andrews, to serve as the School District Solicitor.

The Public meeting dates, time and location for 2018 were approved as shown on the attached schedule.

The Board identified The Citizen, Citizen Way, Bellevue, Pennsylvania, 15202, and the Pittsburgh Post-Gazette, 2201 Sweeney Drive, Clinton, Pennsylvania 15026, as the official school newspaper, either of which may be used for legal advertisements.

The Board appointed Mr. Daniel O'Keefe and Mr. Michael Rajakovic as representatives to the A.W. Beattie Career Center Committee. Also, any interested Board Member may serve and act on behalf of Northgate School District during the absence of appointed representatives.

The Board approved a request from the Bellevue-Avalon Baseball Association (BABA) to use the Bellevue Elementary gym on Monday, Wednesday and Friday evenings, from January 8 through April 20, 2018 from 6:00 - 9:00 p.m.

The Board accepted the resignation of Lisa Bowen as part-time nurse assistant.

The Board approved an addition of a part-time teacher assistant at 32 to 35 hours per week.

The Board approved the Beattie Education Association Settlement.

The Board approved a Translation Agreement with Allegheny Intermediate Unit 3 to provide translation services at \$120 annually and \$1.05 per minute for Spanish interpretation and \$1.25 per minute for all other languages when needed effective February 2018.
